We Cannot Afford to Lose Federal Funding – ALL KIDS COUNT.

Nevada continues to be at the bottom of the education funding levels, but this is more than a state issue – it is also a federal issue. Federal Funding appears to get tied up in the partisan politics as opposed to addressing the issue (a prime example could be IDEA funding – when it passed in 1979 it was "promised" to cover 40%. Today the federal government only seems to cover between 12-16% of the costs connected to the program). Another area (which we have some control over and is not related to the political infighting) is the Census. We have to make sure everyone is counted, especially our under five years old and our children in transition.

The numbers reported are used by the Federal Budget office to project funds over the next ten years needed for the budgets including Title One, Head Start, Free and Reduced Lunch, Career Tech Programs and so many other programs which directly relate to our students success. During the 2010 Census, about 10% of our under 5 year olds were not counted due to parents or guardians (which could include grandparents) confusion (research from Count All Kids). This has serious consequences for our funding when you consider the majority of Washoe Title 1 schools are elementary.

Due to the national political scene there are many who are scared to take the census. To clarify: Your data is SAFE! Personal Census data is kept confidential for 72 years and can ONLY be used for statistical purposes (any current or former Census employee that releases individual data can go to prison for up to 5 years and pay a fine of up to \$250,000); the Census form does NOT have a citizenship question. All residents must be counted.

The timeline of the census – all households will receive a postcard with the information of how to be counted the first few weeks of March. A second postcard will be sent as a reminder. People will be asked to log into a site to be counted by April 30. May-July there will be either an in-person or phone call follow up with Non-Response.

So what can we do? Be informed. Talk about it with each other, our friends, family, parents, even students. Some websites for resources include: census.nv.gov; http://census.gov/; https://censuscounts.org; https://www.census.gov/schools/

Nevada received \$6.1 Billion (or \$2,086 per person) in Fiscal Year 2016 due to the Census. We cannot afford to lose even a portion of this funding.

Update on New WEA/WCSD Contract

We wanted to provide you with a quick update on implementation of the new contract. The following is an overview:

New Contract: WCSD will be printing the new contract soon. We will be sending out several hard-copies of the new contract to our Building Representatives, as well as notifying all WEA members once the new contract is posted and can be referenced on the WEA's web site. To reduce costs, we will not be printing hard-copies to all members.

Salaries (Article 35): The 3% salary increase was included in the December 20, 2019 paychecks, and the retroactive portion of the 3% salary increase was included in the January 22, 2020, paychecks.

Potential 1% Increase (Article 35): We will know in November, 2020, if the up to 1% increase in the salary schedule will be

implemented. The increase could range from .25%, .50%, .75%, to 1.0%, and would be retroactive to July 1, 2020. We attended our first meeting with WCSD's Business Department representatives on December 16, 2019 to review WCSD's financial statements. The next meeting will be on February 24, 2020. We will begin to get a clearer indication if the increase will occur, around May, 2020, which is when WCSD's 3rd quarter financial report will be available.

Substitute Pay for Elementary School Teachers (Article 18.7.1): We are working with WCSD on developing clear guidelines and procedures for the payment of eligible elementary school teachers, based on the new language and based on when a substitute teacher is requested but not available. The goal is to have these guidelines/procedures available for our teachers by July, 2020.

90-Minute Prep Period for Elementary School (ES) SPED Teachers (Article 19.8): We are working with WCSD on developing a survey to send out to a number of ES SPED teachers to determine how often these teachers are or are not being provided the recommended 90-minutes of prep period time each week. Once the survey data is received and compiled, we will be working with WCSD in analyzing the data to determine if additional supports can be provided to our ES SPED teachers.

Overage Process MOU (Article 31.1): We are working with WCSD on reviewing the overage process, with a focus on improving the efficiency and fairness of the process. The WEA will be soliciting members of the WEA to assist in the process, and changes agreed to by WCSD and the WEA will be implemented in the April, 2021 overage process.


Jeff Kirst Innovations High School Teacher Active with the WEA for over 7 years.

Zoom In Not Out

During the 80th Session, SB543, amending Nevada's education funding formula, was introduced late in the Legislative Session, received only one public hearing, and was passed into law over the objections of Nevada educators and numerous other education stakeholders. As a result, the law is riddled with issues, which, if left unresolved before implementation, will only create new winners and losers, rather than improving education for every student.

The bill created an eleven (11) member commission charged with helping implement and making recommendations to the Legislature on Nevada's new school funding plan. The Commission has held several meetings and NSEA has been present and vocal at each one.

From the very beginning, NSEA was clear Nevada's school funding formula needed to be updated to reflect the changing needs of Nevada students. NSEA opposed SB543 during the 80th Session (and currently during the interim) due to serious policy concerns including:

Issue 1: No New/Additional Revenue. Given the chronic underfunding of public education in Nevada, no new funding plan will

work without new and additional revenue.

Issue 2: The Freeze & Squeeze of Most School District Budgets. The bill does not contain a true hold harmless; beginning in 2021, most school district budgets will be frozen without consideration for growth or cost of doing business.

Issue 3: Zoom and Victory Schools Will be Compromised. Under the new funding plan, current Zoom and Victory Schools, two successful equity models, will not be able to maintain their current level of services for students to continue their success. With reduced funding, the current model will be watered down and compromised.

Issue 4: A Multi-Million-Dollar Charter School Giveaway. While freezing funding for most school districts, the windfall for unaccountable charter schools of approximately \$28 million is movement of precious resources away from traditional public schools.

Issue 5: Anti-Union End Fund Balance Provision. Under the new funding plan, 16.6% of a school district's budget will be walled off from collective bargaining (approximately \$740 million Statewide in FY21) This is a gross departure from current practice, and policy of the previous legislative session.

Issue 6: Exclusion of a Current Educator on the Commission. The Commission has significant powers and responsibilities, yet, it is missing an important voice, as no current educator serves on the Commission. Those most impacted by the deliberations and recommendations of the Commission are excluded.

MOVING FORWARD

While NSEA opposes 543 each meeting we attend is an opportunity to advocate for the fixes that are needed for this law to have any chance of success for our kids, our educators, and our state. NSEA has been focused on the various issues mentioned above and have approached each in distinct ways. As part of a broad based coalition, NSEA has also engaged with partners to discuss new sources of revenue so the new formula can have a chance to succeed.

NSEA's campaign of #FIX543, which includes #ZoomInNotOut, is getting stronger, educating the Commission and community during each meeting as to the flaws of this bill. As we head toward the next election and 81st Session, this campaign will guide NSEA as we work to pass and implement a new funding formula that benefits all of Nevada's kids.

WEA Collaboration With U of NEA at UNR

Last March, former ELI fellows, Debbie Deach and Julianne Prettyman, organized a panel of WCSD educators to speak with the university's future educators. Much of the conversation dealt with concerns many of the students had regarding student teaching. The evening proved to be so successful that the WEA Membership Committee has continued the collaboration this year.

On November 20, WEA, working with the WCSD, organized a panel of educators and substitutes to speak about substitute teaching in Washoe County. The WCSD addressed how to go about applying to substitute in Washoe County and educators and current substitutes spoke about the challenges of subbing and offered tips on how to be a successful substitute. Since Washoe County is experiencing a critical shortage of substitute teachers, this was a very timely topic.

Currently, WEA, WCSD and the U of NEA are working together for a second event during Bill Raggio Week at the UNR School of Education, March 9-13. Current plans are to address hiring procedures in the WCSD. Many of the students will eventually be applying for a position here in Washoe County and WEA wants to assist them in being as prepared as possible for that step. Even if these new educators end up applying elsewhere, they will know that local associations are always there to assist them, even from the very beginning of their careers.

WEA looks forward to continuing the growing relationship with the U of NEA and to future endeavors to benefit both associations.

WEA recognizes the importance of identifying our future association leaders and is pleased to continue to encourage the ELI program in other areas of the state. Last year, WEA coached ELI participants in both Mineral and Humboldt counties and will again be working with early educators in Humboldt county. The ELI program assures that the future of our association, both local and statewide, is strong.
